Rules and Regulations of GIFTS Membership

- ❖ All the members and officers are working on a voluntary basis and no payment or remuneration is given to them. Membership is non-transferable and once payment is made, it is non-refundable.
- ❖ In case of loss of ID card and any change in address report to HO in writing.
- ❖ GIFTS will not be responsible for any misuse of an identity card issued to the members during the course of membership.
- ❖ Any kind of misbehavior or misconduct may result in rejection of membership of GIFTS immediately. All disputes subject to the jurisdiction of Delhi only.
- ❖ Strict action will be taken against the member if found guilty as per bylaws.
- ❖ Xerox copy of form acceptable.
- ❖ All members should have to attempt at least 50% programme organized by a particular regional unit of NGO for a claim of a certificate of membership of one year.
- ❖ If a member will attempt every programme actively, in future he/she may be given some responsible position in GIFTS.
- ❖ On expiry, ID card should be returned to HO of GIFTS through the particular area branch. After expiry renewal is a must for regular membership.
- ❖ Along with filled form 2 photos, photocopies of Aadhaar, last qualification degree are a must. If the form is not filled completely it will not be accepted.
